What is this product?

Type

Units of a sub-fund of Fidelity Common Contractual Fund II, an Undertaking for Collective Investment in Transferable Securities (UCITS).

Term

This fund is open-ended.

Objectives

Objective: The fund aims to achieve long-term capital growth.

Investment Policy: The fund obtains exposure to a portfolio primarily made up of listed equities or equity-related securities. The listed equity securities in which the fund will invest may include common stocks, depositary receipts and related securities such as preferred stocks, real estate investment trusts, private placement securities, exchange traded commodities, subscription rights, warrants, equity-linked notes, initial public offerings, secondary offerings, Rule 144A or Regulation S securities, partnership interests and convertible securities.

The fund may also invest, on an ancillary basis, in investment grade government and corporate bonds, convertible bonds and, for cash management purposes, in cash and cash equivalents.

Investment Process: The Investment Manager has appointed a number of discretionary investment advisers as its delegates and will allocate some or all of the fund's assets to such advisers.

In selecting securities, each adviser will take into consideration such factors as economic, legislative, and business developments, market conditions, the presence (or absence) of a given security in an index and the results of bottom-up or top-down analysis, proprietary research or publicly available research.

Derivatives and Techniques: The fund may use derivatives for efficient portfolio management, currency hedging, and investment purposes.

Benchmark: The Sub-Fund is actively managed and references the

SONIA GBP Overnight Index Average annualised for comparative purposes only. The Bank of England SONIA (Sterling Overnight Index Average) is the risk free rate for sterling markets. The SONIA is the effective overnight interest rate paid by banks for unsecured transactions in the British sterling market.

Intended retail investor

This product may appeal to investors with a basic knowledge of and no or limited experience of investing in funds, who plan to hold their investment for a recommended holding period of at least 4 years, who seek capital growth over the recommended holding period and income; and who understand the risk of losing some or all the capital invested.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 4 years.
The actual risk can vary significantly if you cash in at the early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.
