What is this product?

Type

Shares of a sub-fund of Fidelity Common Contractual Fund II, an Undertaking for Collective Investment in Transferable Securities (UCITS).

Term

This fund is open-ended.

Objectives

Objective: The fund aims to achieve long-term capital growth.

Investment Policy: The fund obtains exposure to a diversified portfolio at least two thirds of which will be exposed to listed equities and equity-related securities of companies worldwide.

The listed equity securities in which the fund will invest may include common stocks, depositary receipts and related securities such as preferred stocks, real estate investment trusts, private placement securities, exchange traded commodities, subscription rights, warrants, equity-linked notes, initial public offerings, secondary offerings, Rule 144A or Regulation S securities, partnership interests and convertible securities.

The fund may also invest on an ancillary basis, in investment grade government and corporate bonds and convertible bonds, and for cash management purposes in cash and cash equivalents. The fund may use derivatives for efficient portfolio management and currency hedging purposes, or for investment purposes.

Investment Process: The Investment Manager has appointed a number of discretionary investment advisers as its delegates and will allocate some or all of the fund's assets to such advisers.

In selecting securities, the Investment Manager will take into consideration such factors as economic, legislative and business developments, market conditions, the presence (or absence) of a given security in an index and the results of bottom-up or top-down analysis, proprietary research or publicly available research.

"Benchmark") Used for: performance comparison.

The fund is actively managed and references the Benchmark for comparative purposes only. The Bank of England SONIA (Sterling Overnight Index Average) is the risk free rate for sterling markets.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 4 years.
The actual risk can vary significantly if you cash in at the early stage and you may get back less.
