What is this product?

Type

This is a Luxembourg fund in the legal form of a société anonyme, established as a société d'investissement à capital variable according to the law of December 17, 2010 on undertakings for collective investment.

Term

The fund is a perpetual fund. The Management Company can proceed unilaterally to a redemption of a Share Class of an investor or switch the holding to another Class if the investor no longer meets the qualifying criteria to maintain the Class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all Shares of the relevant Sub-Fund or Class at the Net Asset Value per share for the Valuation Date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or Class.

Objectives

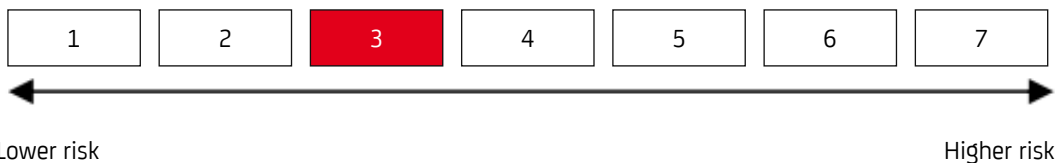
The Sub-Fund invests worldwide in equities of corporates. The balance is invested in EUR denominated bonds of high credit quality (at least investment grade rating issued by reputable credit rating agencies). The selection of both equities and bonds is undertaken on the basis of the Investment Manager's rating methodology in addition to ethical minimum standards. The Investment Manager's rating methodology is thereby based on six core criteria. One star can be awarded for each of these criteria. If a potential investment receives all six possible stars, it is considered an excellent investment, whereby four stars are the minimum for the eligibility of a security. The Investment Manager's core rating and selection criteria in the equity segment include: long-term defensible competitive advantage, solid balance sheet, low dependency on business cycles, capable management, long-term growth prospects and sustainable earnings per share. The selection of sustainable equities and bonds is performed on the basis of the Investment Manager's data service provider. Sustainability factors are integrated into the Sub-Fund's investment process and the Sub-Fund only purchases financial instruments that have been categorised as sustainable by the Investment Manager on the basis of a predefined screening process. The Investment Manager makes the investment decisions for this Sub-Fund by applying sustainability factors on the investment universe defined through the rigorously quality focused screening process. The Investment Manager's investment committee makes centralised asset allocation decisions by way of a majority vote in accordance with the Investment Manager's internally defined rules and based on countercyclical considerations. These asset allocation decisions must be implemented by the Investment Manager. Individual securities are selected based on the Investment Manager's star ratings.

Intended retail investor

This share class is aimed at private clients, professional clients and eligible counterparties. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a medium volatility of the Sub-Fund and potentially capital losses in order to achieve moderate potential investment performances. The sub-fund is intended for investors with a medium-term investment horizon. The investor may bear losses (up to the full loss of the invested capital). The Fund falls into risk class 3 on a scale of 1 (safety-oriented; very low return) to 7 (very risk-tolerant; highest return). Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share issued, less any redemption fee if applicable. This redemption will only be carried out on a Valuation Day. This is a non-distributing share class.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What happens if Structured Invest S.A. is unable to pay out?

The default of the management company will have no direct effect on your fund shares, since the statutory provision provides that in the event of insolvency of the management company, the funds do not enter into the insolvency assets of the management company, but are ring-fenced.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 10,000 is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years.

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives.
