What is this product?

This is a Luxembourg fund in the legal form of a société anonyme, established as a société d'investissement à capital variable according to the law of December 17, 2010 on undertakings for collective investment.

Term

The fund is a perpetual fund.

Objectives

The Fund seeks to generate positive returns by investing across the full maturity and credit spectrum of fixed income securities in developed and emerging markets and within the investment grade and high yield debt markets. The Sub-Fund is actively managed in accordance with the investment restrictions and the following generic investment policy in aiming to achieve its investment objective. The Sub-Fund mainly (at least 80 %) invests in fixed income securities which are denominated predominantly in euros (may also invest in securities denominated in other currencies) and issued by governments, agencies and companies worldwide. The investment process begins with an assessment of macroeconomic factors in order to identify the key medium and long term trends. This is followed by analysis of the fundamentals of the issuers (performance, leverage, relative valuation and so on). The Sub-Fund may hold up to a maximum of 20% in cash and cash equivalents. Bonds of issuers that are classified as "underweight" or "sell" at the time of investment are generally not considered in a purchase decision. In the event of interim downgrades of an issuer to "underweight" or "sell" during the holding period, the individual investment is considered separately on the basis of the respective analyses and a decision is then made as to whether the downgrade necessitates a sale of the respective security. Intended retail investor

The UCITS fund is aimed at private clients, corporate clients and eligible counterparties who are pursuing the objective of general wealth creation/optimization and have a long-term investment horizon of more than 8 years. Investment in the fund is suitable only for investors who are able to assess the risks and value of the investment. The higher long-term potential returns require investors to accept considerable fluctuations in the value of shares and, if necessary, a substantial loss of capital. The investor may bear losses (up to the full loss of the invested capital). The fund falls into risk class 5 on a scale of 1 (safety-oriented; very low return) to 7 (very risky; highest return) in the risk assessment.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Structured Invest S.A. is unable to pay out?
